- II. Officer elections

  - B. Amanda mentioned that a sign up form will be available for people to indicate interest in committee positions for 2021/2022.
- III. Committee Reports
  - A. Fundraising (Wal) popcorn sales were a great success, flower sale is in progress. Rising freshmen have been invited to participate as well (\$9,000 sold to date), orders continue through April 19th. Pick up will be outside of band room on April 29<sup>th</sup>. Looking for a venue and date for the next dine around. There was a motion to move the car wash to August. It passed unanimously.

Sr. banquet & activities (Tina)- Presentation of awards will occur for the Dinner/Senior Serenade on Tuesday, April 27th, at the Amelita Mirolo Barn, event will be live streamed for students that want to watch it. Skit/Karaoke/Activity Night will take place on Friday, April 30<sup>th</sup> at the Whetstone Shelter house.
- IV. New business-

Christine Foulke asked that it be noted that Beth Ryan and Patty Spangler need to be removed from the bank accounts and current officers Amanda Reed (president), Jane Brown (Vice President) and Noelle Fox (Asst. Treasurer) need to be added to the account. There was discussion on the multiple accounts that the band has (ie savings accounts and CD's). Christine requested that the band investigate and potentially consolidate. A motion was made that this be reviewed by the executive board with

consideration from the uniform committee. The motion was amended to include a review the CDs that are maturing and provide a recommendation. Amended motion passed unanimously.

V. Director's Report

Band will not perform live at commencement but will record so that band music will be heard at the event. Mr Fessler talked about logistics of cleaning the current band room and the move. There was discussion of packing the uniforms on May 28<sup>th</sup> and moving to Hastings for storage. Rehearsals for 4<sup>th</sup> of July will be at Hastings. Parade will occur on the 4<sup>th</sup>. Uniform fittings could then also occur at Hastings.

A motion was made to have the band purchase a tree in memorial to the father of a 6<sup>th</sup> and 8<sup>th</sup> grade student. Motion passed unanimously.

Eric Barga extended his gratitude for serving as student teacher.

Camp Swoneky is not available to rent this summer, so band camp will occur locally from August 2 -6. There was discussion of how this will impact the fee structure. The junior class has been notified and is already brainstorming about local activities to supplement the daily activities.

There was discussion about naming rights for the band room, it was mentioned money would likely go to the school and not the band.
